Kompetenzen/Lernziele

This elective course is concerned with the study of Ireland from a historical and contemporary perspective. The country is an interesting case for consideration: the only major English-speaking country in the Eurozone; road distances are given in kilometres yet people drive on the left; the Irish president is not the president of Ireland; the Church of Ireland is not Roman Catholic; the northernmost point on the island is in County Donegal, i.e. in "southern Ireland"! So be prepared for a few surprises ahead.

Recent developments are also of interest. Ireland is now the only country in the world to have legislated for marriage equality by popular referendum. The 1998 Belfast Agreement that ended a 30-year period of civil war is now considered to be a blueprint for conflict-resolution worldwide.

Inhalte

A presentation is a requirement for passing the module, as is regular attendance. After being presented with some information on the historical background to today's Ireland, which participants follow on a timeline, students are then required to give a presentation on any Irish topic of interest to them. Previous presentations have included issues such as the role of women, the Troubles, Gaelic games, folk music, the Irish language and of course the works of Joyce, Beckett et al.

In addition students take an "unseen" paper as a short test. The unseen is part of British academic tradition, especially in the areas of translation and literary studies. A previously unread text dealing with some of the issues raised in the module is given to students to read and then comment on by way of answering some questions. This gives participants a useful insight into some aspects of British academic methodology.
