**First statutes to amend the Study and Examination Regulations issued by  
the Faculty of Energy and Biotechnology for the master's degree  
programme Applied Bio and Food Sciences at Flensburg University of  
Applied Sciences  
dated: 19 June 2020**

On the basis of § 52 para. 1 of the Hochschulgesetz (HSG, Higher Education Act) in the version of the notice dated 5 February 2016 (GVOBl. Schl.-H., page 39), last updated by law as of 13 December 2019 (GVOBl. Schl.-H. page 612) and following the resolution made by the Faculty Board of the Faculty of Energy and Biotechnology on 15 April 2020, the approval of the Senate of FUAS on 18 June 2020 and the permission granted by the President's Office of FUAS on 19 June 2020 the following statutes are issued. These Study and Examination Regulations refer to the provisions made for all faculties of FUAS as defined in the *Prüfungsverfahrensordnung* (PVO, Principles of Assessment) of FUAS in its valid version respectively.

**Article 1**

The Study and Examination Regulations issued by the Faculty of Energy and Biotechnology for the master's degree programme Applied Bio and Food Sciences at Flensburg University of Applied Sciences dated: 15 May 2018 (university bulletin, MBWK, p. 45) are amended as follows:

1. A new paragraph 6 is added to § 3: "Applicants have to provide evidence of an advanced level of German language skills.  
(German as a native language or at level C1)."
2. The former paragraph 6 becomes paragraph 7 in § 3.
3. The sentence "If no such evidence can be provided, applicants can start their studies under the condition that they do provide evidence as listed above no later than by the end of the first semester of their studies." is added to §3 paragraph 7.
4. In § 5, paragraph 2, 2nd semester of the programme the exponent 2 (²) is removed from the module "Project Theory" and added to the module "Team Project".
5. In § 5, paragraph 2, 2nd semester of the programme the form of assessment "WR" is replaced by "WT (1) + Pres".
6. „Biotechnology“ and „Food Technology“ are removed from the Appendix A1.
7. The modules Mathematics, Physics, Chemistry (organic/inorganic), Biochemistry, Biology/Microbiology, Fluid Mechanics, Thermodynamics, Heat and Mass Transfer, Bio Process Engineering, Food Product Technology, Bio or Food Analytics and Food Microbiology/Hygiene as well as the matching headlines "Basics of mathematics and natural sciences", "Basics of

engineering sciences” and “Subject-specific basics”  
are removed from the Appendix A2.

8. The following subjects are added to Appendix A2: Chemistry of biomolecules, Microbiology, Analytics.
9. The sentence “If an applicant needs to make up more than 30 Credit Points from these basics,  
s/he is not considered eligible for admission.” is removed from Appendix A2.
10. In Appendix A 3 and A 4 the name of the degree programmes „Biotechnology and Process Engineering” is replaced by “Bio, Food and Process Technology”.

## **Article 2**

- (1) The first statutes to amend the Study and Examination Regulations will come into effect on the  
day after their publication.
- (2) They are effective for all students enrolling in the Applied Bio and Food Sciences  
master’s degree programme at Flensburg University of Applied Sciences starting from the  
summer semester 2021.
